VOTER REGISTRATION CERTIFICATE

1. After the registrar receives your application, you should receive your voter registration certificate or card within 30 days.
2. Your voter registration certificate identifies you as a registered voter in your precinct and should be presented at the polling place when you vote. Your precinct number appears on the certificate.
3. A current color-coded certificate will be mailed to you in the odd numbered years beginning in the middle of November through the first week of December as long as you remain at the address shown on your current certificate or notify the registrar of any change in your address.

LOST OR MISPLACED CERTIFICATE

1. If you lose or misplace your certificate, notify the voter registrar in writing and a replacement certificate will be issued, or complete a voter registration application and check the box for a replacement certificate.
2. You may vote without the certificate at the polling place by signing an affidavit that you do not have your certificate with you. You must present an acceptable form of identification.

HOW DO I VOTE EARLY

Texas provides convenient early voting in person by any qualified registered voter. Early voting in person begins 12 to 17 days prior to an election and closes the 4th day prior to an election. Early voting polling places are announced in advance in local newspapers and on the Montgomery County Elections website: www.MontgomeryVotes.org

HOW DO I VOTE BY MAIL? (ABSENTEE)

You may vote by mail if you are a qualified registered voter and:

1. You will be away from your county on election day and the entire period of early voting, or
2. You cannot vote at your polling place on election day because of illness, physical disability, age (65 or over), or confinement in jail for other than a felony.

Request a ballot by mail no later than seven days prior to the election.

A separate request is required for each election. Contact the governmental unit calling the election. Mail ballots must be received before polls close on election day.

VOTER REGISTRATION

To register to vote, a person must be

1. seventeen years and ten months or older
2. a citizen of the United States
3. a bona fide resident of Montgomery County
4. mentally competent - not deemed to be incapacitated by a court

Persons convicted of a felony cannot register to vote unless on appeal, granted full pardon, or until after completion of probation, parole, or receipt of certificate of discharge.

A person is eligible to vote 30 days after he or she has registered. Qualified persons may register at the office of the Montgomery County Elections Administrator, at Election Central, 9159 FM 1484, Conroe, TX 77303, between the hours of 8:00 a.m. and 5:00 p.m. Monday through Friday, or by mail. When registering, it is necessary to give a residence address so the person registering can be placed in the proper voting box. Registration is permanent. Changes of address or name should be reported promptly to the Elections Administrator's office.

ELECTION INFORMATION

EARLY VOTING: Early voting ballots may be cast by mail or in person. Detailed information concerning the procedures for casting an early ballot may be secured from the governmental body holding the election.

ELECTION DATES: Municipal, school board and hospital board elections are held on the second Saturday in May unless local political subdivisions select another date. County, district, state, and national elections: Party primary elections are held on the first Tuesday in March of even years. If a run-off election is necessary, it is held on the second Tuesday in April. General elections are held on the first Tuesday after the first Monday in November. Early voting in person begins 12 to 17 days prior to Election Day, 12 days before May elections.
